

"Decoration Loan: Up to HKD8,500 Cash Rebate promotion" Terms and conditions:

「裝修貸款:高達 HK\$8,500 現金回贈」條款及細則:

1. The promotion period of the "Decoration Loan: Up to HKD8,500 Cash Rebate promotion" ("Promotion") is from 1 September 2023 to 30 November 2023, both dates inclusive ("Promotion Period").

「裝修貸款:高達 HK\$8,500 現金回贈」(「本優惠」)之推廣期由 2023 年 9 月 1 日起至 2023 年 11 月 30 日止(包括首尾兩天)(「推廣期」)。

2. The Promotion is only applicable to property owners who directly hold any properties located in Hong Kong under their own names and/or jointly with any third party.

- 3.
